MEMBERSHIP TERMS & CONDITIONS

- This agreement represents the complete understanding between the Member and Bayou View Fitness, LLC. No representations, written or oral, express, or implied, other than those contained within this agreement are authorized by or binding upon Bayou View Fitness, LLC, or its employees.
- The terms of this agreement are for 12 months. Monthly dues for the terms of this agreement shall be _____ per month. Upon expiration of the terms of this agreement, Bayou View Fitness, LLC may adjust the monthly/annual dues.
- Gym members are responsible for their access card. Shared gym access with a non-member will result in forfeiture of membership effective immediately.
- Dues entitle the Member to use the Bayou View Fitness facilities within the scope of the type of membership selected. The Member is obligated to pay monthly dues regardless of whether or not the Member uses Bayou View Fitness.
- Enrollment/Door Key fees are not refundable. Memberships are nonproprietary, non-voting, and nontransferable.
- Member understands that he/she is agreeing to the stipulations set forth on this agreement. Memberships may be canceled by submitting a written letter/email stating one of the following: (1) Proof of Relocation 20 miles or more from Bayou View Fitness (ie Power, cable bill), or (2) Medical reasons with a written request from a medical physician, or (3) 50% of contracts remaining value plus \$50 cancelation fee. - Members may bring guests (\$10 per person per day along with signed waiver), only in accordance with Bayou View Fitness, LLC rules and regulations. Members shall be responsible for the conduct of their guests, and the payment of all charges incurred by those guests.
- Unless Member terminates membership in writing, the membership plan and payment will be automatically renewed as selected above (month-to month or annual) at the expiration of the term set forth below. Dues subject to rates at time of renewal.
- Bayou View Fitness, LLC may suspend or cancel the rights, privileges, or membership of any member whose actions are detrimental to the enjoyment of Bayou View Fitness members.
- The Member will be liable for payment of all costs incurred by Bayou View Fitness, LLC in the collection of of past dues obligations to Bayou View Fitness, LLC, including all court costs and reasonable attorney fees.
- Member acknowledges and accepts the risks inherent in the use of Bayou View Fitness services, facilities, and equipment. By use of Bayou View Fitness, the Member hereby voluntarily assumes the risks of injury, accident, death, loss, cost, or damage to his/her person or property which might arise from the use of Bayou View Fitness. The Members, his/hers heirs, executors, representatives, or assigns, hereby releases Bayou View Fitness, LLC from all claims or liabilities for personal injury or property damage of any kind sustained by the Member further certifies that he/she is in good physical health and able to undertake and engage in the physical exercise or sports activities in which he/she chooses to participate.
- The purpose of this agreement is to insure that the Member understands the duties and responsibilities of Bayou View Fitness's membership. This is a legally binding agreement, therefore:
